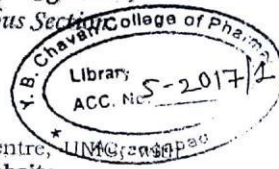

**THEREFORE, I, PROFESSOR B.A. CHOPADE, VICE-CHANCELLOR** of Dr. Babasaheb Ambedkar Marathwada University, in exercise of the powers conferred on me under Section-14[8] of the Maharashtra Universities Act, 1994, in order to regulate the matter urgently hereby direct that the said Ordinances and Regulations shall be effective from the Academic Year 2015-2016 are enclosed as per Appendix-'A'.

**THESE** directives shall have immediate effect and shall be operative till such time as Ordinances & Regulations are to be accepted by the Management Council and Ordinances are to be assented by the Hon'ble Chancellor.
