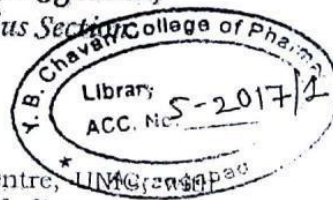

WHEREAS the Academic Council at its meeting held on 30-05-2015 has accepted to adopt the Curriculum of "Choice Based Credit and Grading System" which are already run in University Campus, the same should be implement to the affiliated colleges at Post Graduate level from the Academic Year 2015-2016.

AND

WHEREAS the Ordinances and Regulations are prepared for only to the University Departments who have given academic flexibility. The said ordinances and regulations can not apply as it is to the colleges & recognized institutions.

AND

WHEREAS the Academic Council in the above meeting has accepted the amendments to the Ordinances-885, 886, 887, 888 & 889 and revised Regulations-1927, 1928, 1929, 1930, 1931 & 1932 so as to feasible to implement for the said system to the affiliated colleges and recognized institutions.

AND

WHEREAS the said Ordinances and Regulations are yet to be considered by the Management Council, it will take quite some times and there after the Ordinances to be assented by the Hon'ble Chancellor.

AND

THEREFORE, I, PROFESSOR B.A. CHOPADE, VICE-CHANCELLOR of Dr. Babasaheb Ambedkar Marathwada University, in exercise of the powers conferred on me under Section-14(8) of the Maharashtra Universities Act, 1994, in order to regulate the matter urgently hereby direct that the said Ordinances and Regulations shall be effective from the Academic Year 2015-2016 are enclosed as per Appendix-'A'.

THESE, directives shall have immediate effect and shall be operative till such time as Ordinances & Regulations are to be accepted by the Management Council and Ordinances are to be assented by the Hon'ble Chancellor.


